- I understand that if I have submitted any misleading or falsified work as a part of the academic work which I submit for assessment for my programme of study then the School may terminate my studies forthwith subject to the school academic regulations.

#### 4. Registration requirements

- I understand and agree that I am required to register for the programme of study to which I have been admitted by the date indicated in the offer letter which I have received. The school reserves the right to deny my admission. I also understand that the school reserves the right not to permit me to defer the course for a future point
- I understand, that I will be required to produce all original relevant educational certificates at registration. If this is not possible, I will be required to submit
  attested copies of the original certificates.

#### 5. Attendance and absence from study

- I understand that travel involving a return to my home country or outside of Malta during scheduled teaching semesters/term time is NOT permitted except in the event of exceptional mitigating circumstances. In the event of any mitigating or extenuating circumstances arising I understand that I must inform the School prior to leaving the country or absenting myself from the School and programme.
- I understand that during teaching semesters/term time that there is no leave of absence given for overseas national holidays or attendance at family functions etc.
- I understand that if I travel overseas at any period, this will be done exclusively as permitted by my visa and that I should seek advice from the School prior to booking any such overseas trip.
- · I understand and agree that I cannot change, defer or withdraw from the programme of study offered, without prior written permission from the School.
- I understand, that I am required to maintain a minimum attendance rate of 70%. A failure on my part to do so, could lead to the termination of my registration

#### 6. Academic requirements

#### 6. Academic requirements (Cont.)

- I understand that a postgraduate programme can only be extended by a maximum duration of 6 months and an undergraduate programme a maximum duration of 12 months. Any variations to the above is at the sole discretion of the London School of Commerce Malta.
- I understand that to progress academically I am required to meet the assessment progression requirements of the programme. I understand that the School Regulations only permit a maximum number of assessment failures and that if I exceed this, my registration can be terminated and I may be asked to leave the programme.
- I understand that if I progress from my LSC programme to a University programme delivered at LSC, that once I have been accepted on to that University programme, LSC will not be liable for the academic decisions of the University and hence, I will be bound by the Terms & Conditions and Academic Regulations of the University in place at that time.
- I understand, that If I am required to do Pre-Sessional English, I would need to achieve the required English proficiency level. This is normally B2 level or a proficiency level specified by the academic board. The Pre-Sessional English language course will not normally be extended beyond 6 months of its initial duration. Any further extensions can only be granted only at the sole discretion of the academic board.
